Quick Introduction

When seeking to serve legal documents internationally there are various options. Your legal documents can be served under what is called the Hague Service Convention, Inter-American Convention, or Letters Of Rogatory through the State Department.

The method of service that you decide to use to deliver the legal documents varies based on which country the documents are going to. In addition, the speed of delivery which you require also plays a role in this decision.



Steps 1-6

1. Decide on which category your case falls in: Hague Service Convention, Inter-American Convention or Letters of Rogatory.
2. Send us your documents by email so we can review and provide quote.
3. We will provide a detailed response email with strategy and process.
4. Client submits payment by credit card or check.
5. We prepare application and translation (if necessary).
6. We ship documents and package abroad for service.

The Address

When serving legal documents abroad you want to confirm the address you are going to deliver the documents to is a proper address for service.

If serving a corporation you can Google and investigate the proper address and if necessary contact the company directly. If serving an individual it is necessary that you provide the correct address and that the full address is listed on the Summons. Any problem or deficiency with the address may result in a non-service.

Turnaround Time

When serving through the Hague Convention Treaty-the normal turnaround time is between 2-6 months depending on the country where the defendant is being served. This turnaround time depends solely on the country. For example, to serve in Canada usually it could take 2 months, on the other hand, to serve in China it can take 6 months. This turnaround time depends on the process of that specific country.

When serving under the Inter-American Convention - the process can take from 3-9 months. The extensive amount of time that is necessary under this convention is because the Central Authority forwards the Request for Service application to the Court that has jurisdiction over the defendant.

The diplomatic channels of forwarding and processing your application is more extensive.

When serving Letters of Rogatory through the State Department - this process can take up to 1 year. This process is the most extensive and requires many offices that will review your application for service. This process is necessary when the defendants you are trying to serve are in a country that is not a member to either conventions. Your Letters of Rogatory will be reviewed by the State Department, the Embassy in the foreign country, the Ministry of Foreign Affairs and the Court in that specific country.

Type Of Case

One Important Tip!

You should note that if you are litigating for monetary damages, the only route to serve your legal documents is through the Hague Service Convention, Inter-American Convention or Letters of Rogatory method. Certain countries allow delivery by a private process server but your judgment will not be enforceable. To get started review the table below that will help you identify what service type will suit you best based on your needs and budget.

Translations

Generally there is one additional service you will need when serving legal documents internationally. Certified translations are required for those countries where the official language is not English. Even though your party may speak English when serving defendants in a foreign country, a translation is necessary because the Central Authority and the courts will review your documents in the official language. Our team of international legal translators will ensure that your documents get translated properly.

What You Need (Checklist)

In order to begin the serving process we would need the following:

- ▶ Two sets of the full documents being served (if paying by credit card we will use scanned documents)
- ▶ Summons directed to defendant and issued by the court
- ▶ Complaint (with exhibits--if applicable)
- ▶ A brief summary of the case (2-3 sentences would be sufficient)
- ▶ Cover letter to us with the following information: Name and address of defendant, Name of Judge assigned to matter, address to the court where the answer is due and your FedEx or UPS account number
- ▶ Payment in full payable to Judicial Process and Support, Inc.

Enforcement Of Judgment

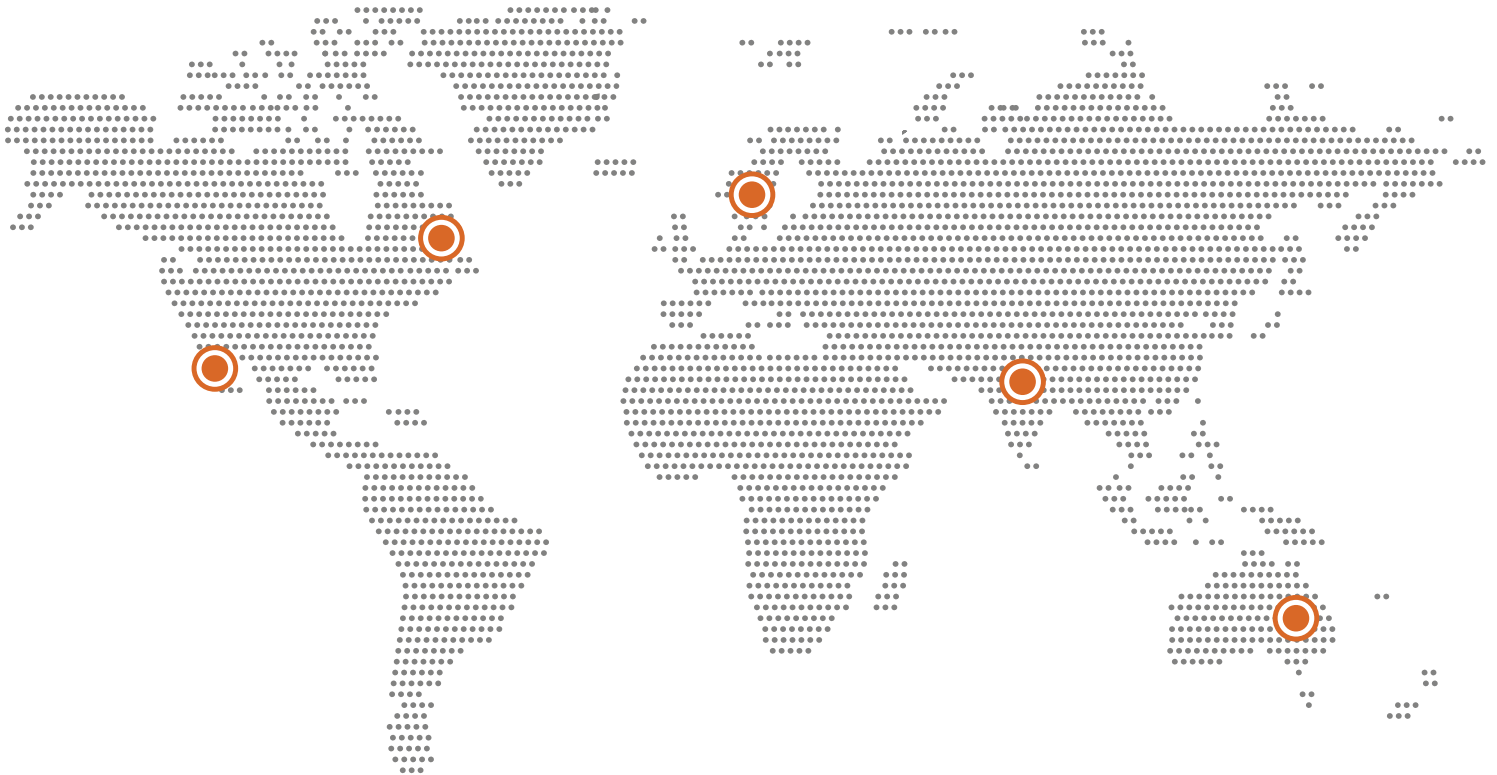
